

This database shall be the property of the DIT and shall not be used for any commercial purpose.

16. The Director, CERT-In shall submit a monthly report of the cases of blocking of the website processed in each month, by 7th of the next month (or the next working day if 7th happens to be a holiday) to the Additional Secretary, DIT.

17. The Director CERT-In shall arrange to make available, the record of the cases of blocking of the website processed by CERT-In, as and when required for audit by an officer designated by Secretary, DIT for this purpose. This inspection/audit may be undertaken on a quarterly basis.

18. The service for blocking of the website containing offending material is to be provided by CERT-In in public interest and hence no fees shall be charged for providing this service.

विषय : उत्तर प्रदेश केबिल टेलीविजन नेटवर्क पर कतिपय शर्तों के अधीन एकमुश्त कर प्रणाली लागू करने के सम्बन्ध में।

महोदय,

उपर्युक्त विषय पर मुझे यह कहने का निदेश हुआ है कि शासन को अधिसूचना संख्या-18/11-क.नि.-6-2004-बीस.एम. (121)/2003 दिनांक 14 जनवरी, द्वारा प्रदेश में केबिल टेलीविजन नेटवर्क पर एकमुश्त कर प्रणाली लागू कर दी गयी है। उक्त एकमुश्त कर प्रणाली निम्नलिखित शर्तों के अधीन लागू करने का निर्णय लिया गया है—

- (1) केबिल आपरेटर द्वारा देय मासिक मनोरंजन कर की धनराशि उनके वास्तविक पाए गए कनेक्शनों की संख्या के सापेक्ष होगा न कि आपरेटरों द्वारा घोषित वर्तमान संख्या के आधार पर एकमुश्त निश्चित (FIX) की जायेगी।
- (2) उक्त कार्यवाही न करने पर अथवा प्राविधान का उल्लंघन करने पर विभाग द्वारा उनके विरुद्ध कार्यवाही उत्पीड़न की परिधि में नहीं माना जायेगा।
- (3) उपभोक्ताओं को विभिन्न चैनलों का मानक प्रदर्शन अथवा दूरदर्शन के तीन चैनल प्राइम बैंड पर दिखाना केबिल आपरेटरों द्वारा सुनिश्चित किया जायेगा। इसके विपरीत पाये जाने पर विभाग द्वारा उनके विरुद्ध केबिल टेलीविजन नेटवर्क (रेगुलेशन) एक्ट, 1995 के प्राविधानों के अन्तर्गत की गयी कार्यवाही उत्पीड़न का परिधि में नहीं माना जायेगा।
- (4) केबिल आपरेटर द्वारा किसी भी उपभोक्ता का कनेक्शन बिना इस निमित्त कारण स्पष्ट करते हुए 15 दिन का नोटिस, जिसकी प्रतिलिपि जिला मनोरंजन कर कार्यालय में भी दी जायेगी, दिये बिना तथा उपभोक्ता का पक्ष जानें बिना नहीं काटा जायेगा।
- (5) यदि बोर्ड उपभोक्ता किसी दूसरे केबिल आपरेटर से कनेक्शन लेना चाहता है तो दूसरा केबिल आपरेटर उसे कनेक्शन देने से मना नहीं करेगा और न ही कोई अन्य आपरेटर ऐसा करने में व्यावधान डालेगा। यदि कोई केबिल आपरेटर जिला मजिस्ट्रेट के किसी आदेश से क्षुब्ध होता है तो ऐसे आदेश के विरुद्ध शासन के समक्ष अपील प्रस्तुत करके अपना पक्ष रखेगा।
- (6) केबिल आपरेटरों द्वारा किसी भी समस्या के लिए सीधे हड़ताल पर जाने से पूर्व उस समस्या का स्पष्ट लिखित प्रत्यावेदन देने तथा कम से कम 15 दिन का नोटिस देने के बाद ही
